With respect to the senior management restructuring of our subsidiary, Pomega Enerji Depolama Teknolojileri A.Ş., the following changes in duties and appointments have been implemented.

Mr. Osman Şahin Köşker, who currently serves as General Manager of Pomega Enerji Depolama Teknolojileri A.Ş., will step down from his position as of January 2026. Mr. Gökhan Serdar is a graduate of Bilkent University, Department of Business Administration. He began his career in audit at Arthur Andersen, followed by roles at Ernst & Young. He later held various senior finance management positions within Yaşar Group, including Dyo and Pınar companies.

In 2014, Mr. Serdar joined the U.S.-based TPI Composites, where he served as EMEA Region CFO, Vice President for EMEA & India, and most recently as Senior Vice President for the EMEA Region. During this period, he led the region's approximately twenty-fold growth, managed the establishment of greenfield manufacturing facilities in India, and successfully executed regional strategic transformation projects.
