Our subsidiary, Plan S Uydu ve Uzay Teknolojileri A.Ş., submitted the most advantageous bid in the tender for the "Procurement of Satellite-Based Communication Unit" conducted by ADM Elektrik Dağıtım A.Ş., and the contract has been signed.

In the initial phase, the project includes equipping 2,000 electricity meters with a satellite-based communication infrastructure and reading the meter data via satellites that we have developed using domestic and national technology, launched into space, and are actively operating in orbit.

This project marks the first implementation of satellite-based communication for electricity meter data transmission in Turkey and has the potential to pave the way for broader applications in the future.

Turkish and English translations of this statement are available, and in case of any conflict between them, the Turkish version will prevail.
